

# FACT SHEET

### Sourcing Organic Ingredients for Processing

Sourcing ingredients for organic processing is sometimes a challenge. Often a convergence of variables impacts how various organic ingredients are sourced and subsequently processed to suit product needs. The objective of this fact sheet is to assist existing and potential organic processors by describing key webbased resources for sourcing organic ingredients for processing.

#### USDA National Organic Program (NOP) List of Certified Operations

  List of all certified organic handlers,
- crop and livestock producers
- Updated annually in January
- Will identify potential sources of a product or ingredient
- Searchable by scope (handling, livestock, or crops-cultivated and wild), by state, and by type of product produced

To find sources of organic bell peppers:

1. Click on the 'Farm-Grown Products' link Farm-Grown Products

organic apples, organic carrots, organic meat...

2. Scroll to the link titled 'peppers, mixed'



An alphabetical list of companies supplying organic peppers will appear.

1. Click on the 'Ingredients' link\*

2. Type 'peppers' into the search box text search

Enter text: peppers Search

3. Click search to view available companies

- Under the Ingredients link, there is a key word list of products and services with lists of sources for whole or raw produce and processed products such as Individual Quick Frozen (IQF), blanched, chopped/diced, cooked, smoked, liquefied, extracts, dried, powdered, etc.

### Other options

- Consider contracting with a grower to secure pricing & availability
- Check with organic certifying agencies many have client listings on their websites
- Contact Trade Associations and Marketing Cooperatives for access to regional producer networks

#### Factors to consider in sourcing organic ingredients

- Per NOP § 205.606, minor non-organic ingredients may be used by organic processors but they must first document their attempts to source the organic forms. Refer to www.606organic.com for options.
- Small to mid-size processors may not receive the best prices based on quantity needs.
- Shipping smaller quantities may increase overall costs.
- Ingredient requirements such as individually quick frozen (IQF) or specific sweeteners may limit availability.
- Processor may need time to ensure organic certification & quality of needed ingredients.
- Other considerations such as sourcing local ingredients may conflict with seasonality and finding a certified organic product.

### REMINDER

Organic processors are strongly encouraged to inquire with the organic certifier to verify a product's organic certification status before making a transaction.
